NEW BUSINESS

Marion Larson added the following information to Dick's report on sharing the harvest. As of early November, through MassWildlife's Hunters Share the Harvest Program, deer hunters in Massachusetts have already donated hundreds of pounds of venison amounting to 3,000 meals to communities facing food insecurity. Hunters can choose to donate a portion of their harvest or their entire deer. Processed venison from the Hunters Share the Harvest Program is distributed through partnering food programs, including the Massachusetts Military Support Foundation's [Food4Vets](#).

In 2022, MassWildlife launched the Hunters Share the Harvest Program with a single venison donation site. For the first pilot year, generous hunters donated more than 1,500 meals of venison to families in need. The venison donation

program is slowly but surely growing with 3 participating meat processors located in Hanover, Fall River, and Groton. There is also a separate venison donation program on Martha's Vineyard. The Groton location is Country Butcher at 68 Boston Rd Groton, MA. Phone is (978) 448-9300.

Any group or individual can support the Share the Harvest Program to help cover the processing and packaging costs for donated meat. By making a monetary donation to the Massachusetts Outdoor Heritage Foundation. A donation of \$50 will provide about 75 servings of meat for families in need.

Donating Your Deer

To be eligible, the deer must be:

- Recovered and field dressed within 4 hours after shot unless the ambient air temperature stays below 37°F.
- Dropped off field-dressed or whole with a participating processor within 24 hours after it is killed.
- Legally reported and tagged with a confirmation number.

Donation Cost

- With the support of donors, hunters who donate their full deer don't pay any processing or packaging fees.
- Hunters can choose to donate a portion of their deer as long as it is processed entirely at an approved processor following all program requirements. Some processors may choose not to accept partial donations.
- Hunters that choose to donate at least 15 pounds of processed venison from their deer will have their deer processing costs reduced by \$50. The processing cost is set by the individual processor.
- Hunters must still purchase required licenses/permits. The costs may be tax deductible as a donation. Discuss with a tax professional.

A motion was made and seconded to spend up to \$6,500 to replace the beverage cooler. After a brief discussion the motion was passed and will be voted on at the December meeting.

As noted under the Board of Directors report we are actively hiring a new caretaker. This is a unique opportunity for the right person. The caretaker is required to live on site and provide their own residence. The club provides a cement pad suitable for a mobile home and septic. The caretaker is responsible for the costs of utilities. In lieu of salary for this position, there is a yearly rental lease of \$1.00. Imagine living rent free? Responsibilities include daily inspection of club buildings, cleaning and stocking of rest rooms, setting up hall for rentals and meetings and cleaning of hall after. Routine ground care to include lawn care, driveway maintenance and snow removal as needed using club provided equipment. Average time required is around 10 hours weekly.
